

**ADDENDUM E**

The following is an amendment to the Area 17 Memorandum of Understanding between the Boards of Mahoning and Columbiana County Commissioners, the Area 17 Workforce Development Board and the OhioMeansJobs Partners for PY 17-18 MOU (July 1, 2017 until June 30, 2019).

**Dynamic Educational Systems (DESI), contractor for Job Corps**, has requested to withdraw from participation as a Mahoning County One-Stop Required Partner.  
The allocation methodology reflects a reduction from 1 FTE to 0 FTE.

- A. Appropriate changes have been made to the cost sharing budget with no escalation in costs to partners other than Mahoning and Columbiana Training Association.
- B. This change is effective as of July 1, 2018.


